FOREWORD

In my academic life of more than twenty years, I have witnessed many important events. It was only later that I realized that these were of a historical nature and had effects that would change the existing world order. I was born in a bipolar world; I took my first step into my professional life at a time when the world was unipolar. I continue my efforts to understand what is happening in today's conjuncture, which is moving towards multipolarity and where uncertainty still prevails. From the day I realized that I was going through life rather than living it, I have been seeking to record and interpret the events I have experienced, observed and witnessed. International Security, the New World Order and Turkey have emerged as a result of my effort to understand and make sense of the global change, transformation and fluctuation in the field of international relations, which is my own discipline in the last twenty years. Undoubtedly, in this process, I saw the significant contribution of different disciplines and approaches in shaping my ideas. First of all, while writing my works, I have always centered the perspective gained by the discipline of sociology as a trademark. Because I believe that a study of international politics that does not take society and people as a reference and is not accompanied by sociological analysis is doomed to be incomplete. Because human beings are the same people in every period and in every culture. Their joys, sorrows, anxieties, and threat perceptions are quite similar. It is also possible to draw parallels between the reaction of states to events and human behavior. However, these reactions are often irrational and tend to take shape outside the thick and clear lines determined by logic. This situation also makes it difficult to understand international relations, which is a social science. In this context, actor analysis and process analysis are parameters that must inevitably be consulted in order to reduce the margin of error in forward-looking projections, and history is a magnificent laboratory. It would probably be an illogical and overly optimistic assessment for me to claim that I have fully and completely analyzed a huge issue that concerns a multi-actor, multi-layered, highly dynamic and wide period of time and that I have made accurate predictions for the future. This study has been written with the aim of comprehending the international system only through selected and specific topics, giving an idea about the possible trajectory/orientation of international actors, and discussing through which security policies and threat perceptions the construction of a new world is possible. The work will have achieved its goal to the extent that it can inspire other studies to be carried out on this subject.
